Due to the unprecedented situation with the COVID-19 pandemic, charities can vote to amend their constitution, allowing AGM meetings to be conducted virtually. Everyone present voted in favour of amending the PTFA constitution.

Chairs report:

Tilli & Teri provided an overview of 2019/20 fundraising activity. It has been a very challenging year for fundraising as many of the planned events couldn't take place due to the COVID-19 situation. However, a small number of events went ahead, maintaining some income. There were also significant contributions from successful grant applications. A full report is available separately.

The Chair & wider committee wanted to thank everyone who has supported the PTFA during the 2019/2020 year.

Treasurers report:

Jon provided an overview of 2019/20 financial situation. At the end of the 2019/2020 year, the current account stood at £16,356.71. A significant proportion of this total came from grants and as such is ringfenced for specific projects (sensory garden & allotments). Overall, there was a net loss of approximately £2000 for this financial year due to missed fundraising events because of COVID-19. A full report is available separately.
